- If the Laminated Glass is subjected to standing water or other liquids
- If the Laminated Glass product is damaged or altered by handling, storage, fabrication, or installation contrary to industry standards and incorporated by reference to GANA (Glass Association of North America) and AAMA (American Architectural Manufacturers Association) or equivalent
- If the Laminated Glass is attacked by incompatible glazing lubricants, glazing soaps, incompatible glazing gaskets, glazing sealants, incompatible cleaning fluids, moisture or building runoff, gluing or insulation, or exposure to solvent or chemical fumes
- The use of Portland cement-based products not recommended for use with SentryGlas laminates. Please review sealant compatibility list for glass railing installations.
- If the Laminated Glass was discarded or destroyed
- If the Laminated Glass is installed in water craft, solar collectors, or commercial refrigeration products
- If the Laminated Glass PVB Interlayer is cut with the assistance of flammable liquids, either ignited or non-ignited
